Monitoring of GMO Dealings involving Intentional Release (DIR)

During the quarter the OGTR inspected **1 GM plant field trial site** (**Table 1**). The inspections comprised:

- Current field trial sites Of the **5** sites current in the quarter, **1** was inspected.
- Post-harvest field trial sites Of the **24** sites subject to post-harvest monitoring in the quarter, **none** were inspected.
