

Classification of Notifiable Low Risk Dealings (NLRDs) – NLRD reporting form requirements

Requirements for classifications of NLRDs:

For the assessment of an NLRD to be considered complete (as required by the NLRD reporting form), it needs to have all of the elements shown below in the “Requirements” column for the specific classification.

NLRDs suitable for at least physical containment level 1 (PC1)

Gene Technology Regulations 2001 - Schedule 3, Part 1, 1.1

Classification	Requirements	NLRD reporting form submission notes
(a)	Must only be listed as (a) to be considered complete.	(i) and (ii) will not be shown as options for this classification.
(c)	Must include both (i) and (ii)(A-B) to be considered complete.	If (c) is selected, then (i) and (ii)(A)-(B) will automatically be selected.

NLRDs suitable for at least physical containment level 2 (PC2)

Gene Technology Regulations 2001 - Schedule 3, Part 2, 2.1

Classification	Requirements	NLRD reporting form submission notes
(a)	Must include both (i) and (ii)(A) - (E) to be considered complete.	If (a) is selected, then (i) and (ii)(A) - (E) will automatically be selected.
(aa)	Must include both (i) and (ii) to be considered complete.	If (aa) is selected, then (i) and (ii) will automatically be selected.
(b)	Only (b) applicable	N/A
(c)	Must include (i) – (iv) to be considered complete.	If (c) is selected, then (i) - (iv) will automatically be selected.
(d)	Must include (i) - (iii) to be considered complete. (i)(A) – (D) do not need to be specified for this classification to be considered complete.	If (d) is selected, (i) – (iii) will be automatically selected. (i)(A) – (D) are not able to be selected on the form as these are not mandatory.
(e)	Must include (i) and/or (ii) to be considered complete.	If (e) is selected, one or both of (i) or (ii) must be selected.

	(ii)(A) – (D) do not need to be specified for this classification to be considered complete.	(ii)(A) – (D) are not able to be selected on the form as these are not mandatory.
(f)	Must include both (i) and (ii) to be considered complete.	If (f) is selected, then (i) and (ii) will automatically be selected.
(g)	Only (g) applicable	N/A
(h)	Must include (i) and/or (ii) to be considered complete.	If (h) is selected, one or both of (i) or (ii) must be selected.
(i)	Only (i) applicable	N/A
(j)	Must include both (i) and (ii) to be considered complete.	If (j) is selected, then (i) and (ii) will automatically be selected
(k)	Must include both (i) and (ii)(A) – (B) to be considered complete.	If (k) is selected, (i), (ii)(A) and (ii)(B) will be automatically selected.
(l)	Must include (i), (ii) and either (iii)(A) or (iii)(B) to be considered complete.	If (l) is selected, (i) and (ii) will be automatically selected. (iii)(A) or (iii)(B) must be selected manually.
(m)	Must include (i)(A) – (B), (ii), (iii) and either (iv)(A) or (iv)(B) to be considered complete.	If (m) is selected, (i)(A), (i)(B), (ii) and (iii) will be automatically selected. (iv)(A) or (iv)(B) must be selected manually.
