

## Application for a licence

# for inadvertent dealings with a genetically modified organism (GMO)

If you have inadvertently come into possession of a GMO, you should contact the Office of the Gene Technology Regulator (OGTR) on 1800 181 030 or by email as soon as possible. OGTR staff will discuss your situation and options, including any additional authorisations that you may need.

There are no penalties for accidently possessing a GMO; however, it is an offence under the *Gene Technology Act 2000* (the Act) to knowingly deal<sup>1</sup> with a GMO without the appropriate authorisation. This includes destroying the GMO; however, if the Regulator is satisfied that you came into possession of a GMO unintentionally, you may apply for an Inadvertent Dealings Licence that allows you to dispose of the GMO in an appropriate way.

### Information

### What information do we need from you?

The application form includes a number of questions about the GMO, including what it is, why you think it is a GMO, and questions that help to provide a full description of the organism. You should provide as much information as you can in answer to these questions, making sure that the information is correct to the best of your knowledge. If you have any supporting evidence such as reports or scientific papers, you should provide information on those as well.

You must answer each question unless otherwise instructed; however if you don't know the answer to a question, there are options to indicate that. You will also need to provide a contact name and details. These are needed so that we can keep you informed about the progress of your application or to discuss the application and the information with you.

### Accuracy of information

The information you provide in this application must be true and accurate. The Act (and corresponding state law) provides for imprisonment and fines where a person gives information to the Regulator that the person knows to be false or misleading. If you are unable to answer some questions, you should indicate this on the application form.

#### Is there an application fee for an inadvertent dealings licence application?

No, there is no application fee.

We may contact you to request further information, and will send you a notification once the Regulator has made a decision on this application.
