#### **Condition 20a**

Nuseed continues to develop the regulatory package for NS-B50027-4 with studies required for deregulation in other world areas. There has been no new information pertaining to any adverse impacts, unintended effects or risks.

An example of this is that Europe require animal feed dietary exposure modelling, hence we are using the protein expression values already presented to the OGTR to model canola meal in feedlots in Europe. Europe also require a different statistical package for the composition and agronomy data, hence new reports are being generated. The Europe statistical package has not shown anything different or adverse for either composition or agronomy. To date nothing adverse or unintended has been found to change the risk profile of NS-B50027-4.

#### **Condition 20b**

There have been zero hectares of NS-B50027-4 grown for commercial purposes.

#### **Condition 20c**

Two sites were planted over winter in 2019 in Victoria for non-commercial (research) purposes. The combined planted area of the two trial sites is 3.74 hectares.

Nuseed continues to develop the regulatory package for NS-B50027-4 with studies required for deregulation in other world areas. There has been no new information pertaining to any adverse impacts, unintended effects or risks.

An example of this is that China requires the protein expression study to be conducted on three different generations. Nuseed submitted a study to OGTR on one generation and the expression of the proteins was only found (by design) in the immature seed and mature seed fractions of the crop. We have completed another generation (including segregants – EU requirement) which showed the same result, and a third generation is being analysed now. Other studies, including but not limited to toxicology, animal feeding, composition and agronomy, are being conducted. To date nothing adverse or unintended has been found to change the risk profile of NS-B50027-4. Condition 20b

There have been zero hectares of NS-B50027-4 grown for commercial purposes.

#### **Condition 20c**

Six sites were planted over winter in 2018 in Victoria for non-commercial (research) purposes. The combined planted area of the six trial sites is 5.073 hectares.

An additional site 1733\_PAT (Site 33 DIR123) was transitioned from DIR123 to DIR155. At the time DIR155 was issued, Nuseed had a research nursery site growing in the field with NS-B50027-4. A request was made to the OGTR to sign-off on DIR123 Site 33, given only NS-B50027-4 had been planted at this site and the issuing of DIR155 which covered NS-B50027-4. Sign-off for DIR123 Site 33 was granted by the OGTR on 05Mar2018. The planted area of this additional site under DIR155 was 0.235 hectares.

At all times, Monsanto remained an accredited organization and complied with the Act and with its instrument of accreditation.

## Applicant to notify of circumstances that might affect suitability

During the reporting period, Monsanto Australia Ltd did not receive a relevant conviction occurring after the commencement of this licence; nor was there any revocation or suspension of a licence or permit held by Monsanto Australia Ltd under a law of the Australian Government, a State or foreign country, being a law relating to the health and safety of people or the environment; or any event or circumstance occurring after the commencement of this licence that would affect the capacity of Monsanto to meet the conditions of the DIR127 licence. Monsanto acknowledges that it must provide information related to its ongoing suitability to hold a licence, if requested, within a time period stipulated by the Regulator.

## Informing people of their obligations

Monsanto Australia Proprietary Limited informed all persons covered by the DIR127 licence of the obligations imposed on them as a result of the conditions of the licence. This was primarily achieved through implementation of the Monsanto Stewardship policy which includes training and information on regulatory obligations and management of the crop. This requires persons having management responsibility for TruFlex Roundup Ready canola crops to undergo training.

Monsanto recognizes that any persons covered by the DIR127 licence, to whom a particular condition of the licence applies, must be informed of particular conditions and any variations, the cancellation, suspension or surrender of the licence. This is achieved through training and contractual obligations.

During the reporting period, Monsanto Australia Ltd did not become aware of any risks to the health and safety of people, or to the environment, associated with the dealings authorised under DIR127; or of any contraventions of the licence by a person covered by the licence; or any unintended effects of the dealings authorised by the licence.
